#### From the Desk of Managing Trustee...

Hello Everyone,

Meeting after a break of 4 years.... 2020-2023, three years, no dialogue, no communication, just like a quiet world! Covid 19 badly affected the whole world in terms of inter personal relationship, communication, personal meetings, gatherings and much more.



Make My Dream Foundation continued its journey during these three years with steady pace. Covid 19 emerged with some out of the box challenges. During first phase of covid / lockdown we ensured that all our candidates have secured and safe stay. In some cases we sent them back to their hometowns. With the help of various NGO's, personal donations, government sources, we supplied them monthly grocery so that their family should at least have food. We raised funds through special fund-raising drive for those who lost the jobs / were not getting monthly payments regularly during this period. In the next stage, we focused on their vaccination.

Covid 19 had diverse effect on overall education system, classroom study, in person admission process, final examinations and quality education. As an NGO, we had also witnessed major setback in candidates admission, monitoring their schedules, systematic payment of their tuition fees, payment of room rent and mess bills. The chaotic situation continued till November 2021. Slowly recovery started and candidates got admitted online in colleges and then approached us for financial help.

The online study / education System witnessed a extreme usage of technology. We monitored and ensured that all our candidates have minimum gadgets for online education. However, 2020-2021 was a very challenging year with disruptive education and confusing results.

During academic year 2021-2022, candidates adapted to the online system and overall education system also recovered with good speed. Our admission process also got smoother & we tried to overcome the new challenges swiftly.

However, we had to curtail many indoor / outdoor activities considering these special ones who need extra care during this bad patch. We got an opportunity to accomplish challenging projects during this patch. Number of cochlear implant cases approached us and we are happy to state that we have successfully accomplished annually one case of cochlear implant since 2020. Also, we accepted challenge of corrective surgery of club feet case of ex candidate Rangnath Gadekar and completed it successfully in 2021-2022.

Unfortunately, we had to reduce many indoor / outdoor activities considering these special ones who need extra care during these challenging times.

We were able to get accomplish some medical successes during this time. We have successfully done annual case of cochlear implant since 2020. In 2021/22 we accomplished a complex/challenging corrective surgery for club feet case of ex candidate Rangnath Gadekar.

"Of course, the projects we had accepted during these three years are of huge fund requirements. So, I am deeply indebted to the kind gesture of our domestic and foreign donors, CSR partners, who offered unreserved support to all the ventures we have undertaken during this period.

We saw education systems restoring in academic year 2022-2023 proved to be restored education system and good number of students approached us for financial help. We were able to help about 20 students. We are happy to state that we could explore support to 11 hearing impaired candidates in current year. For the first time, we accepted the challenge of taking these hearing impaired ones in trekking expedition. All have enjoyed a Korigad Fort trek and the expedition went well beyond imagination. Few ex-students got the employed during this year, few got married and thus their life got streamlined. Overall, a win-win situation in current academic year.

Under our Mobility Project, we have extended the scope of project by supplying a special modified vehicle to ex candidate Sagar Bharat. Our aim seems to be imbibed by the ex- candidates and they are honestly following the Make My Dream Foundation's values.

During this period, we have extended support to blind candidates also. So, we are on the path to our main objective of inclusive candidates. We are happy to offer support to candidates with loco motor disability, Hearing Impaired, Blind and Cerebral Palsy.

About "Gurukul" – the project couldn't progress further due to Covid 19 restrictions. Now as the restrictions are over, we expect to speed it up shortly.

Finally, I am deeply indebted to all our supporters, CSR partners, well-wishers, volunteers and management team, who offered robust support in all our endeavors. I am confident to continue this journey with you all with the same zeal and zest.

## "Mobility Project"....An Initiative with Different Perspective

Make MY Dream Foundation is always in thrust of providing better opportunities to its candidates of 'self reliance' with need based financial support. An envision idea of providing interest free vehicle loan emerged out of in depth thought of their 'self reliance' and self dignity. In 2014, we have provided special vehicles to 3 ex-candidates i.e. Irfan Pathan, Yuvraj Ahire and Sunita Shinde under this project. "Ear Marked Fund" amounting to Rs.2,40,000/= created out of special donations received from donors against "Mobility Project".



We are proud to state that all have repaid the loan in full. Further, in 2017 we have extended the scope of project to Akash Dasgude and Suresh Rathod by providing the specially modified vehicles. Suresh have repaid the loan in full and in case of



In November, 2020, we have further extended the scope of project to Sagar Bharat by providing the specially modified vehicle. He started repaying since January, 2021.

**Success:** Success of the project lies in recycle of funds and making responsible the candidates towards timely repayment of debt. It reduces indirect financial burden on the government and society.



Omkar Ranjit Kadam, from Gajawadi village, was born partially deaf, missing an outer ear and ear canal in both sides. This congenital defect is called bilateral microtia with bilateral moderate to severe conductive hearing loss. BAHA- Bone Anchored Hearing Aid Implants, transmit the sound waves through the bones in our skull, or bone conduction, thereby bypassing the outer and middle ear. MMDF decided to get enhanced BAHA implants (1.3 tesla), which offer patients a high level of MRI compatibility.

In 2016, MMDF engaged Dr. Hetal Marfatia, ENT Surgeon from K.E.M. Hospital, Mumbai, for the surgery. She also helped for fund raising. Tata Trust aided Rs. 3.63 lakhs, and Murli Laj Chungai Charity Trust Rs. 0.40 lakhs.





MMDF raised funds of around Rs. 1 lakhs towards the project.

In August 2016, the operation was performed successfully. After completion of Austio Integration in November 2016, Omkar started hearing normally. BAHA Implant made him to be a part of mainstream society.

Omkar is now pursuing B. Arts and is doing fine academically.

We are very much grateful to the team of doctors, volunteers and donors who helped to make the project happen successfully.

#### Speech Processor - Project I - 2017

Purva Kadam from Baramati is a case of bilateral congenital profound sensory neural 100% hearing loss. In January 2009, Purva underwent Cochlear Implant surgery at KEM Hospital, Pune under the guidance of Dr. Neelam Vaid, ENT Consultant. Purva integrated in normal school and started communicating near normal speech. Cochlear Implant helped her to become part of mainstream society.



Speech Processor provided to Purva in 2009 got out of production and its functioning was affected. Hence Purva was advised for up gradation of her external speech processor. The cost of new speech processor was at Rs. 5,58,750/=. Purva's mother being sole earning member in the family approached MMDF for financial assistance. She puts own contribution of Rs. 3.00 lacs and the supplier company gave discount of Rs. 0.50 lacs. MMDF raised funds of Rs. 2.09 lacs towards the gap and successfully completed the project in December 2017.

Purva completed her 10th standard successfully and pursuing paramedical education at Baramati.

#### Cochlear Implant - I (In the year 2020)

Master Saksham Sachin Chougule from Pune, a 2.5 years old boy, a case of bilateral profound sensorineural hearing loss. Doctor suggested Cochlear Implant for his both ears. Cochlear Implant is a device which bypasses the defective hair cells in the inner ear and directly simulates the auditory nerve (Hearing Nerve). It involves surgical insertion and post operative rehabilitation. It is advisable to have Implant to the child at early age and so that the child can develop his language fast due to post implant rehabilitation.

Total cost of the Implant (Basic Version), Surgery and post surgery Rehabilitation was estimated at Rs. 12.83 lacs for both the ears. Against the same the parents have received Rs. 5.20 lacs as Government aid and help of Rs.2.20 lacs from Mukul Madhav Foundation, Pune. The parents have put Rs. 3.00 lacs as own contribution and approached us to support the gap. MMDF raised funds of Rs. 1.975 lacs i.e. the gap and for the rest amount, the hospital gave discount.

The surgery was performed in March, 2020 at Moraya Multispecialty Hospital, Chinchwad by Dr. Avinash Wachasundar, ENT Surgeon. Saksham has been provided with external sound processors for both the ears and his rehabilitation is going on. He started listening and his language is developing

with good pace. He will develop near normal Speech and Language very soon and will also get formal education by integrating to regular school.

We are very much grateful to donor's who contributed for this noble cause. #### Cochlear Implant - Project II - 2021



Master Sanket Suryawanshi from Village Kalandi, Latur, a 20 years old boy, born with normal hearing and speech ability. At the age of 15 he caught with viral fever and lost his hearing ability of both the ears in the trauma. He got diagnosed with bilateral severe to profound sensorineural hearing loss by Dr. Wachasunder. Doctor advised Cochlear Implant for at least one ear to regain his hearing ability and be part of mainstream society.

Cochlear Implant is a device which bypasses the defective hair cells in the inner ear and directly simulates the auditory nerve (Hearing Nerve). It involves surgical insertion and post operative rehabilitation.

Total cost of the Implant (Basic Version), Surgery and post-surgery Rehabilitation was estimated at Rs. 6.80 lacs for one ear. Against the same the parents have contributed Rs. 2.00 lacs and received help of Rs.1.00 lacs from Mukul Madhav Foundation, Pune. The parents have approached us to support the gap. MMDF raised funds of Rs. 2.80 lacs against the gap and for the rest amount hospital raised donation.

The surgery was performed in July, 2021 at Moraya Multispecialty Hospital, Chinchwad by Dr. Akshay Wachasundar, ENT Surgeon. Sanket has been provided with external sound processor for operated ear and his rehabilitation is going on. Master Sanket has successfully completed ITI education & is doing job in electric shop.

#### Cochlear Implant - Project III - 2022



**Master Utkarsh Manoj Kurne** from Nashik, a 2.6 years old boy has been diagnosed as bilateral profound sensorineural hearing loss. Doctor suggested Cochlear Implant for his both ears.

Cochlear Implant is a device which bypasses the defective hair cells in the inner ear and directly simulates the auditory nerve (Hearing Nerve). It involves surgical insertion and post operative rehabilitation.

Total cost of the Implant (Basic Version), Surgery and post-surgery Rehabilitation was estimated at Rs. 14.78 lacs for both the

ears. Against the same the parents have received Rs. 4.68 lacs as Government aid, help of Rs.0.70 lacs from Mukul Madhav Foundation, Pune and Rs. 1.00 lac from Ekam Foundation, Mumbai. The parents have collected Rs. 1.50 lacs as own margin and approached us to support the gap. MMDF raised funds of Rs. 6.90 lacs i.e. the gap.

The surgery was performed in January, 2022 at Moraya Multispecialty Hospital, Chinchwad by Dr. Akshay Wachasundar, ENT Surgeon. Utkarsh

has been provided with external sound processors for both the ears and his rehabilitation is going on. He started listening and is developing slowly. He will develop near normal Speech and Language very soon and will also get formal education by integrating to regular school.

#### Cochlear Implant - Project IV - 2023



Master Mohsin Firoz Shaikh from Pune, a 20 years old boy was born normal and had normal hearing by Right Ear and speech ability but he was having profound hearing loss in Left Ear since childhood, which remained untreated by his parents. At the age of 18, Mohsin was caught by viral infection of cough and cold, which affected hearing ability of Right Ear and started reducing with faster pace. His parent tried a lot to get back his hearing ability since then with the use of amplifications and treated by few specialist doctors but nothing turned positive. Mohsin was provided with powerful hearing aid but not benefitted even then. His audio logical evaluations confirmed that he has Post Lingual Right Ear profound hearing loss. Doctor suggested Cochlear Implant for his Right ear immediately so as to retain his normal speech ability. He is pursuing final year of Diploma in Animation, which is also affected due to increasing hearing trauma.

Cochlear Implant is a device which bypasses the defective hair cells in the inner ear and directly simulates the auditory nerve (Hearing Nerve). It involves surgical insertion and post operative rehabilitation.

After evaluation, Dr. Mandke recommended Nucleus TSE Sound Processor with Nucleus Profile Slim st. Electrode (C1522) version implant for his Right Ear.

Total cost of the Implant, Surgery and post-surgery Rehabilitation was estimated at Rs. 12 lacs for Right ear. Against the same the parents have received assurance / help from Indorewala Memorial Educational And Medical Institute & Research Centre (IMEMIRC), Nasik Rs. 5 lacs in the form of Government aid and asked the parent to arrange for Rs. 7 lacs. Out of Rs. 7 lacs parent have collected Rs. 4.75 lacs as own margin and approached us to support the gap. MMDF raised funds of Rs. 2.25 lacs.

The surgery was performed in February, 2023 at Indorewala ENT Hospital, Nasik by Dr. Shabbir Indorewala, ENT Surgeon. Mohsin has been provided with sound processor for Right ear and his rehabilitation is going on. He started listening immediately and he resumed to his Diploma course.

We are grateful to donor's who contributed for this noble cause. 
#### **UNIQUE PROJECTS**

#### **Corrective Surgery**

Master Rangnath Gadekar is under our support program since academic year 2016-2017. He completed Bachelor in Fine Arts successfully with the help of our financial support.

He is a patient of club feet since birth. His congenital deformity remained untreated since childhood. Over the period it got worsened and left with painful walking for him.

After completion of his education, Make My Dream Foundation decided to help him for corrective surgeries of both the feet. He then directed to Dr. Gowerdhan Ingale, Orthopedic Surgon of Ramkrishna Hospital, Pune. After assessment doctor opined that Rangnath need multistage



multiple k wires with corrective casts at stage 2.

The overall time required for surgery and recovery of both feet estimated at ' and 1/2 year.

The surgery of Right Feet took place in June / July 2021 and after complete recovery of the Right Feet, surgery (stage 1) of Left Feet took place in March 2022.

Now Rangnath is leading a normal walk with the use of calipers. Both the surgeries have improved his personal and functional life to a great extent.



#### ABOUT MAKE MY DREAM FOUNDATION

Make My Dream Foundation was established on 27th March, 2009 with an object of complete rehabilitation of physically disabled children prevailing from economically weaker section. Make My Dream Foundation aims at:

- Empowerment of the physically challenged children through education & self-reliance and imbibing in them self-confidence to be a part of an inclusive society.
- ◆ Develop basic infrastructure for divyang persons to have hassle free life.
- Create awareness in the society about genuine needs of various divyang categories and offer them varied opportunities to live dignity life.
- Establish a complete Rehabilitation Center for the physically challenged children.

In the financial year 2022-2023 considering our upcoming project of "Gurukul" a residential center, we have extended our object to rehabilitation of physically normal candidates prevailing from economically weaker section so as to comply with inclusive society in real sense.

#### Phase I - Current Project

In phase I, we provide support to 10th passed students for higher / vocational education and motivate them through counselling to lead self-reliant and dignified life.

Up till now we have completed rehabilitation of 40 candidates and about 35 candidates are getting benefitted under our rehabilitation program for past four years i.e. during 2019-2023. We support them financially till they complete mainstream education. Our financial support program includes educational expenses, accommodation, conveyance, study material and other requisites. We motivate them to follow healthy life style.

Initially we expose them to aptitude test and counsel about various available options consistent with their aptitude. Candidate themselves decide stream of education and we support their decision. We guide in their admission process to regular colleges and get them expose to inclusive education.

Our candidates pursue education in any stream like engineering, fine art, commerce, tourism, horticulture, crèche and pre-school management, cookery, music and electronics / IT.

We are proud to state that out of 40 candidates, whose support program has been completed, about 35 candidates are leading self-reliant life. Of them few are leading happy married life and few are pursuing competitive examinations.

We constantly imbibe in them that they are just physically challenged and mentally they are perfectly normal. Through counselling, we make them aware that just because of their financial weak condition, society is offering them various opportunities through the platform of Make My Dream Foundation and in future they will ensure to repay the debt of society by creating varied opportunities to the fellow sufferers.

#### Phase II - Upcoming Project - Gurukul

Make My Dream Foundation has decided to initiate its Dream Project "Gurukul": An Independent Beginning. Gurukul will be a residential facility towards support and strengthening of the physically challenged (divyang) as well physically normal candidates prevailing from economically backward category. Gurukul will have approximate 20000 sq. Ft. Construction on 1 Acre Land capacity to house about 50+ candidates and requisite caretakers. It will be situated within the vicinity of Pune City. It will also be developed as a residential cultural centre.

Gurukul will have following features:

- Residential arrangement closely situated to Regular Schools and Colleges.
- Vocational Training Unit.
- ♦ Medical Care Unit, Pre & Post Operative Care Unit, Recovery Unit
- Physiotherapy, Gymnasium and Yoga Unit
- Prosthetic Limb Manufacturing Unit
- Library (including Brail books), Audio Room (for Hearing Impaired), Music Room, Art and Craft Section, Computer Lab, Auditorium and Swimming Pool
- Horticulture, Solar Driven Projects, Water Recycling, Bio Gas Energy and Eco-Friendly Environment

#### For Severe Disabled Persons

Various Income Generating Projects will be generated within the campus of "Gurukul" to lead them self-reliant and Dignified Life.

#### Income Source

Our income source is through donations received from public only. We have not opted for any Government grant or aid. We have tried to reach many of deprived candidates through our support program.

We feel deeply indebted to all the donors of Make My Dream Foundation from the bottom of heart for their unreserved support in all our endeavours.

Your, generous and kind help is playing and will have a precious and key role always. In present scenario incremental expenses is expected for pursuing college education.

#### Sound Processor - Project II - 2022



Tanishka Raykar from Pune, of age 17 is born with normal hearing and speech ability. She caught by meningitis at her age of 9 years and lost her hearing ability of both ears in the trauma.

In 2016, Tanishka underwent Cochlear Implant surgery at KEM Hospital, Pune under the guidance of Dr. Neelam Vaid, ENT Consultant. Tanishka integrated in normal school and started communicating near normal speech. Cochlear Implant helped her to remain part of mainstream society.

Sound Processor provided to Tanishka in 2016 got out of production and its functioning was badly affected in October 2022 requiring huge amount for repairs. Hence Tanishka was advised for up gradation of sound processor. The cost of new sound processor was of Rs. 3,12,900/=. Tanishka's father being sole earning member in the family approached MMDF for financial assistance. He raised hand loans and put own contribution of Rs. 2.00 lacs but still shortfall of Rs. 112900.00. MMDF raised funds of Rs. 1.00 lacs towards the gap and successfully completed the project in December 2022. Dr. Kalyani Mandke of Mandke Hearing Services allowed deferment in payment of balance amount of Rs. 12,900/=.

Tanishka is pursuing her 11th standard Arts at S. N. D. T. College, Pune. She could continue her education with our timely help.
